- Monitor well installation completed; monitor well sampling and gauging completed; laboratory analyses completed; data validation completed.
- All monitor wells (including two installed by others), vapor wells, and staff gauge surveyed by licensed land surveyor.
- Data Evaluation Summary Report for the Expedited Area completed and submitted; Environmental Protection Agency (EPA) and Indiana Department of Environmental Management (IDEM) comments received and addressed in Draft Expedited Area Remedial Investigation (EA RI) report.
- Draft EA RI completed and submitted on March 27, 2017; EPA and IDEM comments received on April 28, 2017.
- Data Evaluation Summary Report for the LaSalle Park Area completed and submitted on April 4, 2017; EPA and IDEM comments in process.
